2. Functions of State Skill Upgradation Council of H.P. would be:-
  - i) That State Skill Upgradation Council will function as an Apex planning body to advise the concerned authorities to identify skill gaps amongst the target groups entering the job market and those working in the un-organised sector.
  - ii) The Council will advise to formulate and review State Skill upgradation Action Plan for the 12<sup>th</sup> Five Year Plan (2012-17) and Annual Plan 2012-13 as per sectoral skill upgradation outlay and targets set by the National Council on Skill Development.
  - iii) The Council will advise the department for starting of new schemes to achieve the objectives of skill upgradation in the State from time to time.
  - iv) The Council will advise on the skill upgradation strategy for the self employment sector in the different departments.
  - v) In order to promote employability of women, the Council will advise on the skill upgradation strategy to enhance the employability of women in the self employment & wage employment sectors.
  - vi) The Council will advise an incentive mechanism to encourage private sector to participate in skill development in the state and also government owned/supported training providers e.g., CIPET, MSME tool rooms, ATDC, NAC, etc.
3. The Headquarter of the Council will be at Shimla.
4. State Skill Upgradation Council would meet periodically to discharge the above functions.
