If the technical proposals for each study are not submitted in separate sealed envelopes, proposal will be rejected.

Please also provide technical proposal and its annexure(s) (scanned copy in one PDF file) in a CD/DVD; along with a hard copy of the proposal. Please note that CD/DVD should not contain financial proposal.

Your proposal must be expressed in English language and valid for a minimum period for one year.

In the course of preparing your proposal, it shall remain the organization's responsibility to ensure that it reaches the address above on or before the deadline. Proposals that are received by HP HDRCS after the deadline indicated above, for whatever reason, shall not be considered for evaluation.

Proposals shall be reviewed and evaluated based on completeness and compliance of the proposal and responsiveness with the requirements of the RFP and all other annexes providing details of HP HDRCS requirements.

The proposals that comply with all of the requirements and meet all the evaluation criteria shall be selected for inviting financial bids. Any offer that does not meet the requirements shall be rejected.

All the proposals submitted as a result of this RFP shall be subject to the General Terms and Conditions attached hereto. The mere act of submission of a Technical Proposal implies that the organization accepts without question the General Terms and Conditions of HP HDRCS, herein attached as Annex 3.

Please be advised that HP HDRCS is not bound to accept any proposal for, nor be responsible for any costs associated with preparation and submission of a proposal, regardless of the outcome or the manner of conducting the evaluation process.

HP HDRCS encourages every prospective organization to submit the proposals. Annexure-3

General Terms and Conditions for Services

1.0 LEGAL STATUS:

The Contractor shall be considered as having the legal status of an independent contractor vis-à-vis the Himachal Pradesh Human Development Resource Coordination Society (HP HDRCS). The Contractor's personnel and sub-contractors shall not be considered in any respect as being the employees or agents of HP HDRCS or the Government of H.P.

2.0 SOURCE OF INSTRUCTIONS:

The Contractor shall neither seek nor accept instructions from any authority external to HP HDRCS in connection with the performance of its services under this Contract. The Contractor shall refrain from any action that may adversely affect HP HDRCS or the Government of H.P. and shall fulfil its commitments with the fullest regard to the interests of HP HDRCS.

3.0 CONTRACTOR'S RESPONSIBILITY FOR EMPLOYEES:

The Contractor shall be responsible for the professional and technical competence of its employees and will select, for work under this Contract, reliable individuals who will perform effectively in the implementation of this Contract, respect the local customs, and conform to a high standard of moral and ethical conduct.

4.0 ASSIGNMENT:

The Contractor shall not assign, transfer, pledge or make other disposition of this Contract or any part thereof, or any of the Contractor's rights, claims or obligations under this Contract except with the prior written consent of HP HDRCS.

5.0 OFFICIALS NOT TO BENEFIT:

The Contractor warrants that no official of HP HDRCS or the Government of H.P. has received or will be offered by the Contractor any direct or indirect benefit arising from this Contract or the award thereof. The Contractor agrees that breach of this provision is a breach of an essential term of this Contract.

6.0 INDEMNIFICATION:

The Contractor shall indemnify, hold and save harmless, and defend, at its own expense, HP HDRCS, its officials, agents, servants and employees from and against all suits, claims, demands, and liability of any nature or kind, including their costs and expenses, arising out of acts or omissions of the Contractor, or the Contractor's employees, officers, agents, in the performance of this Contract. This provision shall extend, inter alia, to claims and liability in the nature of workmen's compensation, products liability and liability arising out of the use of patented inventions or devices, copyrighted material or other intellectual property by the Contractor, its employees, officers, agents or servants. The obligations under this Article do not lapse upon termination of this Contract.

7.0 ENCUMBRANCES/LIENS:

The Contractor shall not cause or permit any lien, attachment or other encumbrance by any person to be placed on file or to remain on file in any public office or on file with the HP HDRCS against any money due or to become due for any work done or materials furnished under this Contract, or by reason of any other claim or demand against the Contractor.

8.0 COPYRIGHT AND OTHER PROPRIETARY RIGHTS:

- 8.1 Except as is otherwise expressly provided in writing in the Contract, the HP HDRCS shall be entitled to all intellectual property and other proprietary rights including, but not limited to, copyrights with regard to products, processes, inventions, ideas, know-how, or documents and other materials which the Contractor has developed for the HP HDRCS under the Contract and which bear a direct relation to or are produced or prepared or collected in consequence of, or during the course of, the performance of the Contract, and the Contractor acknowledges and agrees that such products, documents and other materials constitute documents made for the HP HDRCS.
- 8.2 To the extent that any such intellectual property or other proprietary rights consisting of an intellectual property or other proprietary rights of the Contractor: (i) that pre-existed the performance by the Contractor of its obligations under the Contract, or (ii) that the Contractor may develop or acquire, or may have developed or acquired, independently of the performance of its obligations under the Contract, the HP HDRCS does not and shall not claim any ownership interest thereto, and the Contractor grants to the HP HDRCS a perpetual license to use such intellectual property or other proprietary right solely for the purposes of and in accordance with the requirements of the Contract.
- 8.3 At the request of the HP HDRCS; the Contractor shall take all necessary steps, execute all necessary documents and generally assist in securing such proprietary rights and transferring or licensing them to the HP HDRCS in compliance with the requirements of the applicable law and of the Contract.
- 8.4 Subject to the foregoing provisions, all maps, drawings, photographs, mosaics, plans, reports, estimates, recommendations, documents, and all other data compiled by or received by the Contractor under the Contract shall be the property of the HP HDRCS, shall be made available for use or inspection by the HP HDRCS at reasonable times and in reasonable places, shall be treated as confidential, and shall be delivered only to HP HDRCS authorized officials on completion of work under the Contract.

9.0 USE OF NAME, EMBLEM OR OFFICIAL SEAL OF HP HDRCS OR THE GOVERNMENT OF HIMACHAL PRADESH (GoHP)

The Contractor shall not advertise or otherwise make public the fact that it is a Contractor with HP HDRCS, nor shall the Contractor, in any manner whatsoever use the name, emblem or official seal of HP HDRCS or the Government of H.P., or any abbreviation of the name of HP HDRCS or the Government of H.P.in connection with its business or otherwise.

10.0 FORCE MAJEURE; OTHER CHANGES IN CONDITIONS

- 10.1 In the event of and as soon as possible after the occurrence of any cause constituting force majeure, the Contractor shall give notice and full particulars in writing to the HP HDRCS, of such occurrence or change if the Contractor is thereby rendered unable, wholly or in part, to perform its obligations and meet its responsibilities under this Contract. The Contractor shall also notify the HP HDRCS of any other changes in conditions or the occurrence of any event that interferes or threatens to interfere with its performance of this Contract. On receipt of the notice required under this Article, the HP HDRCS shall take such action as, in its sole discretion; it considers to be appropriate or necessary in the circumstances, including the granting to the Contractor of a reasonable extension of time in which to perform its obligations under this Contract.
- 10.2 If the Contractor is rendered permanently unable, wholly, or in part, by reason of force majeure to perform its obligations and meet its responsibilities under this Contract, the HP HDRCS shall have the right to suspend or terminate this Contract on the same terms and conditions as are provided for in Article 11, "Termination", except that the period of notice shall be seven (7) days instead of thirty (30) days.
- 10.3 Force majeure as used in this Article means acts of God, war (whether declared or not), invasion, revolution, insurrection, or other acts of a similar nature or force.
- 10.4 The Contractor acknowledges and agrees that, with respect to any obligations under the Contract that the Contractor must perform in or for any areas in which the HP HDRCS is engaged in, preparing to engage in, or disengaging from any peacekeeping, humanitarian or similar operations, any delays or failure to perform such obligations arising from or relating to harsh conditions within such areas or to any incidents of civil unrest occurring in such areas shall not, in and of itself, constitute force majeure under the Contract.

11.0 TERMINATION

- 11.1 Either party may terminate this Contract for cause, in whole or in part, upon thirty (30) days notice, in writing, to the party.
- 11.2 HP HDRCS reserves the right to terminate without cause this Contract at any time upon 15 days prior written notice to the Contractor, in which case HP HDRCS shall reimburse the Contractor for all reasonable costs incurred by the Contractor prior to receipt of the notice of termination.
- 11.3 In the event of any termination by HP HDRCS under this Article, no payment shall be due from HP HDRCS to the Contractor except for work and services satisfactorily performed in conformity with the express terms of this Contract.
- 11.4 Should the Contractor be adjudged bankrupt, or be liquidated or become insolvent, or should the Contractor make an assignment for the benefit of its creditors, or should a Receiver be appointed on account of the insolvency of the Contractor, the HP HDRCS may, without prejudice to

any other right or remedy it may have under the terms of these conditions, terminate this Contract forthwith. The Contractor shall immediately inform the HP HDRCS of the occurrence of any of the above events.

12. SETTLEMENT OF DISPUTES

Amicable Settlement: The Parties shall use their best efforts to settle amicably any dispute, controversy or claim arising out of this Contract or the breach, termination or invalidity thereof. Where the parties wish to seek such an amicable settlement through conciliation, the conciliation shall take place in accordance with the procedure as may be agreed between the parties.

13. PRIVILEGES AND IMMUNITIES:

Nothing in or relating to this Contract shall be deemed a waiver, express or implied of any of the privileges and immunities of the Government of Himachal Pradesh, HDRCS and its organs.

14. OBSERVANCE OF THE LAW:

The Contractor shall comply with all laws, ordinances, rules, and regulations bearing upon the performance of its obligations under the terms of this Contract.

15. SEXUAL EXPLOITATION:

The Contractor shall take all appropriate measures to prevent sexual exploitation or abuse of anyone by it or by any of its employees or any other persons who may be engaged by the Contractor to perform any services under the Contract. For these purposes, sexual activity with any person less than eighteen years of age, regardless of any laws relating to consent, shall constitute the sexual exploitation and abuse of such person. In addition, the Contractor shall refrain from, and shall take all appropriate measures to prohibit its employees or other persons engaged by it from, exchanging any money, goods, services, offers of employment or other things of value, for sexual favours or activities, or from engaging in any sexual activities that are exploitative or degrading to any person. The Contractor acknowledges and agrees that the provisions hereof constitute an essential term of the Contract and that any breach of this representation and warranty shall entitle HP HDRCS to terminate the Contract immediately upon notice to the Contractor, without any liability for termination charges or any other liability of any kind.

16. AUTHORITY TO MODIFY:

Pursuant to the Financial Regulations and Rules of HP HDRCS, only the HP HDRCS Authorized Official possesses the authority to agree on behalf of HP HDRCS to any modification of or change in this Contract, to a waiver of any of its provisions or to any additional contractual relationship of any kind with the Contractor. Accordingly, no modification or change in this Contract shall be valid and enforceable against HP HDRCS unless provided by an amendment to this Contract signed by the Contractor and jointly by the HP HDRCS Authorized Official.

Terms of References (ToRs)

1 - “Study on Human Development for inclusive and Sustainable Green Growth in Himachal Pradesh”

Objectives

To undertake a study to assess the overall level of Human development achieved in the State of Himachal Pradesh over the last decade following a life cycle approach to human development. The study should also focus on the impact of environmental changes and potential impact of environmental policy on human development, and to institutionalize integration of human development in the planning process in Himachal Pradesh achieve faster, environmentally sustainable and inclusive growth.

Comment [1]:

Background and Rationale:

A small predominantly hilly State of Himachal Pradesh started its development journey in 1971 when it was conferred with the full Statehood. Himachal Pradesh has an area of 55,673 square kilometers and a population of about seven million people (2011 Census). About 90% of its population lives in the rural areas of the State. In a short span of about forty years Himachal Pradesh has earned a distinction of being one of the most progressive hill State of the Union of India. Annual growth rate in the gross state domestic product (GSDP) and the per capita income are the best economic indicators to know the economic status of any economy. The per capita income of Himachal Pradesh (Rs. 65,335 at current prices for 2010-11) has been perpetually higher than the national average (Rs. 53,331 at current prices for 2010-11). Relatively higher growth rates of Himachal's economy and also higher per capita income of Himachal Pradesh are indicative of effective implementation of the development policies of the Government. The progress made by the State in terms of availability of health and education facilities has been impressive during last forty years. Despite belligerent geo-climatic conditions, the physical infrastructure availability in the State has improved remarkably. Efforts of the State Government in conservation of environment have been acknowledged globally.

Taking a lead in reducing the carbon emissions and earning carbon credits for the same, Himachal Pradesh has emerged as the first State in the country to march towards achieving carbon neutrality. The State has taken various steps to protect the environment and achieve carbon neutrality. The hilly state has earned the distinction of being a trendsetter in development issues.

Environmental degradation and climate change are intrinsically and intricately linked to human development as the prudence used in management of natural resources is the major determinant of the development path of a society. The recent UNDP Asia Pacific Regional Human Development Report on 'Sustaining Human Progress in a Changing Climate' provides factual evidence to demonstrate that 'climate change threatens further progress in poverty reduction and it could also render already hard-won human development gains unsustainable.

For a progressive State like Himachal Pradesh, economic growth will remain a priority for next one or two decades, but the need is to combine efforts towards increasing average incomes together with ensuring sustainable natural resource use. The increasing requirements of rapidly changing life styles of the population of the State need to be

reconciled with development planning through more judicious natural resource management and environmental conservation.

The Human Development: Towards Bridging Inequalities (HDBI) project of the Planning Commission and UNDP is focused on assessing the status of human development from multiple perspectives in order to identify challenges to progress and identify viable solutions. With poverty and inequalities set to intensify further with environmental degradation and climate change, it appears necessary to understand human development from the perspective of environmental sustainability and the potential impacts that climate change and environmental degradation may have on human development.

The Government of Himachal Pradesh has also entered a partnership with the Planning Commission of India and the UNDP under the aegis of the HDBI and has undertaken to implement a project - Human Development in Himachal Pradesh with Inclusive Green Growth and Sustainable Development with the objectives having broad synergy with the objectives of the national level project. The First Human Development Report of Himachal Pradesh was brought out in the year 2003 and now it has become an imperative to document the developments that have taken place in the field of human development in Himachal Pradesh.

It is in this background that a study is proposed under the project, to (a) study to assess the overall level of Human development achieved in the State of Himachal Pradesh over the last decade following a life cycle approach to human development, and (b) to institutionalize integration of human development in the planning process in Himachal Pradesh to achieve faster, environmentally sustainable and inclusive green growth.

Scope of work

The proposed study will be undertaken for Himachal Pradesh to:

1. Make an assessment of the overall level of Human development achieved in the State of Himachal Pradesh over the last decade following a life cycle approach to human development.
2. Analyze and document linkages between human development and environmental sustainability by examining dominant environmental concerns in the State's context and the manner and extent to which they impact human development indicators and exacerbate inequalities.
3. Analyze the detrimental effects of environmental degradation on the poorer and vulnerable sections taking into account the extreme weather patterns, climate change and environmental changes.
4. Examine the extent to which the environmental concerns are integrated into planning for human development at the national (in recent five year plan) & state level (Himachal Pradesh).
5. To record people's perception about human development and its linkages with the environmental policy and climate change.
6. Analyze the existing policy framework on the process of human development and the environmental concerns and to make recommendations based on the findings of the study.

The agency/organization will submit an inception paper to the Planning Department within two weeks of issuance of the contract. The agency/organization is expected to organize periodic stakeholder's consultations during the course of the assignment so as to ensure that the all the concerns of all the stakeholders get covered duly.

2 - “Study to Explore the Causes of Declining Sex Ratio in the Age Group of 0-6 Years”

Objectives

To map the trends in Sex Ratio particularly in the age group of 0-6 years and to explore into the causes of decline in the sex ratio in the age group of 0-6 years during the last two decades in Himachal Pradesh.

Background and Rationale

Most societies in the industrialized world have a healthy 0-6 child ratio i.e. there are roughly the same number of girls and boys in the 0 – 6 age-group. In India however, the rapidly declining sex-ratios are turning into a demographic nightmare of frightening proportions.

The sex ratio of 927 in the 0 – 6 age group is only the national average for India. There are areas within the country where the ratio has dropped to well below 900. The ratios for some of the states are: Himachal Pradesh 896, Punjab 793, Chandigarh 845, Uttaranchal 906, Haryana 819, Delhi 865, Rajasthan 909, and Gujarat 879. These are not the most economically backward areas of the country. On the contrary, Punjab, with the lowest 0 – 6 sex-ratio in the country, is the most economically prosperous state of India. Delhi, the national capital region of India, has a declining 0 -6 sex-ratio. In fact, some of the poorest states have a sex-ratio well above the national average. The decline in the sex ratio in the age group of 0-6 years in Himachal Pradesh was reported in the Census 2001 data.

Several reasons are attributed to the decline in the number of girls – neglect of the girl child, high maternal mortality, female infanticide and now, female foeticide. Sex-selective abortions have been greatly facilitated by the misuse of diagnostic procedures such as amniocentesis that can determine the sex of the foetus.

The prejudice against the girl child continues to be an issue of concern for the Government of Himachal Pradesh, which, has started several incentive based initiatives besides strictly implementing the provisions of the PNDT Act to address the problem of female foeticide. As a result of these initiatives of the State Government the declining sex ratio has been reversed as per the Census 2011 data. However there is much required to be done on this front which needs to be preceded by establishing the reasons for this decline in the State.

The study is one of the steps in meeting the objectives of the project – Human Development for Inclusive and Sustainable Green Growth in Himachal Pradesh being implemented in the State under the umbrella of the national project – Human Development for Bridging Inequalities being implemented jointly by the Planning Commission and the UNDP.

4. In depth exploration into the causes of decline in sex ratio in the age group of 0-6 years in Himachal Pradesh.
5. Analysis of the existing policy framework in Himachal Pradesh that aims at arresting the declining trend in the 0-6 year sex ratio.
6. Policy recommendations to improve the sex ratio in the age group of 0-6 years in Himachal Pradesh.

3 - “Financial Report Card on Human Development in Himachal Pradesh”

Objectives

- a. to undertake analysis of financial allocations and expenditure by various Government Departments directly engaged in the process of Human Development in Himachal Pradesh
- b. to examine if the expenditure incurred by the Departments has actually translated into the desired outcomes contributing to further the process of human development in Himachal Pradesh
- c. to make projections on the financial requirements (both in private and Government sectors) during the next five years for meeting the targets set during the Twelfth Five Year Plan period of Himachal Pradesh

Background and Rationale

Himachal Pradesh scores reasonably high on the indices of Human Development in comparison to other many other developed States of the country. The educational achievements, in particular, are impressive; health indicators are generally better than those for the country as a whole and the State has been able to reduce the poverty levels substantially. The efforts on the front of promotion of gender equity has met a considerable success in Himachal Pradesh. One of the factors which have contributed to the achievements made in the field of human development in Himachal Pradesh has been consistently high public expenditure on human development during the last two decades or so.

The available information indicates that the State's development is almost entirely driven by the public sector investment. Without going into the issue of desirability of greater private sector involvement and contribution to development in Himachal Pradesh, it can safely be inferred that the health of State's finances have considerable influence on the path of development of the State. By virtue of being a Special Category State, Himachal Pradesh has to consistently rely on the Central transfers to keep its finances stable and enabling it to meet the resource requirement for achieving higher levels of human development in the State. Achieving the targets set in the Twelfth Five Year Plan document of Himachal Pradesh is the real challenge with the State Government besides maintaining the level of achievements already made by the States in the field of human development.

4 - “Study to Assess the Socio-Economic Status of Gujjars in Himachal Pradesh”

Objectives

To undertake the study for assessment of the socio-economic status of the Nomadic Gujjars in Himachal Pradesh. Gujjars of Himachal Pradesh have been traditionally depended on the livelihood strategies that revolved around rearing and management of buffaloes. It would also be an endeavor to explore into the possibility of adoption to other alternative livelihoods strategies which could improve and uplift the socio-economic status of the Gujjars of Himachal Pradesh.

Background and Rationale

Under the provisions of the Indian constitution the Gujjars are notified as a Scheduled Tribe (ST) in Himachal Pradesh. The Gujjar economy revolves around the buffaloes, and they survive by selling milk and milk products to settled villagers. They often rely on middlemen, to whom many are now indebted. As nomads, the Gujjars have difficulties proving land ownership, and often face eviction from their camp sites. Although some of the Gujjars have been reported to have settled down and have resorted to pastoralism. Their children either stay at home or accompany them during migratory periods. The level of literacy among the Gujjars is low especially for girls.

The Twelfth Plan document of Himachal Pradesh stresses upon to achieve faster and more inclusive growth. One of the ways that could help in achieving this goal is to uplift the socio-economic status of the underprivileged sections of the society. Appropriate policy formulations follows the assessment of the situation.

The study is also one of the steps in meeting the objectives of the project – Human Development for Inclusive and Sustainable Green Growth in Himachal Pradesh being implemented in the State under the umbrella of the national project – Human Development for Bridging Inequalities being implemented jointly by the Planning Commission and the UNDP.
